Vision

VoiceCoin™ unlocks the latent social and economic value of the human voice. By tokenizing everyday speech through explainable Al and secure blockchain infrastructure, VoiceCoin™ enables people—especially elders, caregivers, teachers, and underrecognized communities—to transform conversations, caregiving, and life storytelling into redeemable, traceable value. This defines a new class of digital asset: Vocal Value. Voice data has value to Al and diagnostic companies for improving lives.

Problem

Billions of hours of spoken value are lost every day:

Elders, caregivers, and people like teachers' and parents' guidance is undervalued.

Al threatens to replace voice-based human jobs, without alternatives for human-centered value creation.

Solution

VoiceCoin is the first system that:

- Converts spoken moments into traceable, redeemable VoiceCoins using Dasion's Geometric Unified Learning (GUL) engine
- Maps voice events to diagnostic, educational, or relational value, then tokenizes them
- Offers a secure blockchain-based wallet to store and redeem tokens
- Enables legacy preservation through voice storytelling,
 Al-written life books, and emotional heritage

Our solution builds the world's first Voice Economy, where talking becomes earning, and empathy becomes currency.
